1-Executive Summary of Progress Report**
As of 31 March 2015

A. Summary of Activities

A.1 Project Overview

In December 2004 the Royal Government of Cambodia (RGC) adopted the Public Financial Management Reform Program (PFMRP), which is a long-term reform program based on stage/platform approach that addresses the overarching and systemic public financial issues. It remains a sector-wide approach.

On 07 November 2013, Public Financial Management Modernization Project (PFMMP) was established to build on the successes of the ongoing Public Financial Management and Accountability Project (PFMAP). Total proposed project cost is USD 12 million, agreed to be financed by standalone Recipient Executed Trust Fund (RETF), Investment Project Financing (IPF) under the Public Financial Management Trust Fund. The initial periodic contribution from the donors to this trust fund is covering the period from November 07, 2013 to May 14, 2016 in the amounts of US\$ 5,903,013 under the Grant No.TF015434.

The project development objective is to enhance public financial management through two main components: (i) strengthening revenue mobilization strategy and implementation monitoring and (ii) improving budget execution process through the acquisition and implementation of FMIS. Summary of activities under these components is highlighted below.

A.2 Progress Activities

Based on the no-objection from the World Bank in an email dated 23 February 2015, total approved Annual Work Plan and Budget (AWPB) for PFMMP in 2015 is in the amount of USD 10.24 million. Concerning the upcoming additional financing in the amount of USD 7.5 million to the Grant No.TF015434, the total approved figure is quite different from the fund balance which is only USD 3.15 million. While waiting for additional financing to be approved, the budget allocation to each project category may be more than the initial allocation in the lifecycle budget.

In the first 1st quarter of 2015, PFMMP Project disbursed only USD 276,411.86 or 46% comparing with the quarterly budget of USD 604,029.05. The significant decrease in disbursed amount, comparing with the previous quarter, is mainly due to the slow payment request from FMWG for the FMIS Contract which represents sub-component 2.1 and takes a big share of the grant proceeds. The table below shows the summary figure of budget vs. actual expenditure by project component for the 1st Quarter of 2015. On the other hand, the delay in the preparation and approval process of the Consolidated AWPB can result in low disbursement rate in the first quarter of 2015.

Progress of Component 1

Component 1.1: Mobilization of Revenue

Total budget under this sub-component in the amount of USD 37,500 was anticipated to support General Department of Internal Audit (GDIA) for the ongoing support provided by technical assistants and training activities. As a result, GDIA could disburse up to USD 36,243.61 or 97% comparing with the budget. International Internal Audit Advisor and IT Auditor continue to provide technical support to GDIA under the assigned tasks. There were two main training activities conducted as the following:

- *Training on “Guideline for the Conduct of Audit Assurance Assignment”* was held from 12 January-12 February 2015 for officials from MCS, MoI, NBC, MCFA, MoT, MoWRAM, MoSALVY & MNASRL. It was divided into three sessions with about 20 participants in each session. It's designed to assist internal auditors from LMs to select and plan a pilot risk based audit assurance assignment, conduct the audit, report the assignment results to management and follow up audit work. The same training will also be conducted for other Line Ministries in the next quarter.
- *Workshop on “Audit IT Application”* was conducted on 05-06 February 2015 for enhancing the capacity of Internal Auditors on software audit program, IT monitor system, ongoing audit program system, IT structure of auditing and audit on FMIS system. There were about 116 participants attending the training in which female participation represented 16% of the total.

Component 1.2: Implementation Support-GSC

Under the ongoing implementation support of PFMMMP, GSC could totally disburse in the amount of USD 74,565.71 or 92% of the planned budget of USD 80,823.50. The slightly differences was due to the fact that there was saving amount from conducting the 2nd GCS Retreat which was held at Kampot Province on 22-24 January 2015. Moreover, some training and workshop activities are postponed to the next quarter. Major progress activities during this reporting period are highlighted below.

- *Consolidated AWPB:* the AWPB for year 2015 was prepared based on the GDAP2-New. After getting AWPB from relevant General Departments of MEF, GSC had come up with the Consolidated AWPB for submitting to the World Bank on 11 February 2015 for review and approval. Therefore no-objection was given on 23 February 2015. To speed up

the action plan implementation, upon getting final approval from H.E Minister, GSC sent a notice to all relevant General Departments of the approved AWPB on 13 March 2015. In addition, GSC will also plan to convince a meeting to introduce the budget implementation process in April 2015.

- *Supplementary Financial Management Manual (SFMM)* was prepared by updating the Administration Manual to reflect the changes in Financial Management Manual, condition in the Grant Agreement of PFMMMP as well as experiences gain from the previous project implementation. The document was submitted to the World Bank on 20 March 2015. After getting no-objection from the World Bank as well as approval from H.E Minister, GSC will organize the training on SFMM for representatives from General Departments and GSC Specialist and will seek technical assistants from the World Bank in this regard.
- *World Bank Implementation Support Mission*: was conducted on 02 February 2015. With constructive recommendation on Financial Management, GSC will improve internal control on Petty Cash Invoice, 3 Quotation Process and vehicle management.
- *Internal Audit*: General Department of Internal Audit had conducted internal audit on PFMMMP project during the period from 09 Feb – 06 March 2015. GSC will send a copy of the Internal Audit Report to the World Bank for information after getting the document from the GDIA.
- *External Audit*: BDO (Cambodia) Limited had conducted their audit field work during the 2nd week of March 2015. Management Letter and Audited Financial Report for Year 2014 would be finalized by May 2015.
- Following several meeting and discussion related to finance, procurement and other technical issues, GSC arranged a negotiation meeting for the additional financing to the Grant No.TF015434 on 26 March 2015. GSC will continue to facilitate the signing process of the Contract Agreement.

Progress of Component 2

Component 2.1: Budget Execution Process and Core Treasury System

In this quarter, the project disbursed only USD 61,372.30 or 17% of the planned budget of USD 370,000. Payment for FMIS Contract usually based on the actual goods and services provided and the amounts claimed vary from time to time. This usually leads to the huge differences between the actual and plan budget. While more goods and services are being delivered and waiting for approval from FMWG during the first quarter, the project anticipates that the disbursed amounts will be increased in the coming quarter. FMIS progress can be summarized based on the 5 major phases as below.

Component 2.2: FMIS Implementation Support

To support FMIS Implementation, the project disbursed USD 104,230.24 or 90% comparing with the budget of USD 115,706. These were mainly spent on training activities and National and International Consultants who provide on-going support to FMWG in FMIS contract management. Since the AWPB was approved in late February 2015, some training activities were behind the schedule. This led to differences between the plan and actual disbursement.

Under the PFMMP's financial support, one official from GDB was sent to attend Public Expenditure Management Network in Asia Budget Community of the practice (PFMNA-B-CoP) in order to have in-deep exchanges experience and lesson learn for current changes that Cambodia is moving towards Performance Based Budgeting System.

In addition, based on the case by case no-objection from the World Bank, FMWG and GSC Management will attend oversea training on *Reform Communication - Leadership, Strategy and Stakeholder* in order to strengthening critical communication skills and tools required to support PFM activities and to acquire critical skills for strategic communication development that lead to the development result.

B. Variance Analysis by Disbursement Category Items

The Table below shows the financial performance under each category of PFMMP by comparing the actual disbursed amounts against the budget projection in the reported quarter.

Goods-FMIS: FMWG has managed day-day implementation of the contract and payment to contractor, FPT Information System, by adhering to Implementation Schedule, Price Schedule, and Inventory Table. No payment is paid without the delivery and acceptance of goods supplied. During this quarter, more goods and services were being delivered and waiting for approval from FMWG. Therefore, payment for the completed works will be shown in the next quarter report. In this regards, the project could disburse only USD 61,372.30 or 17% of the planned budget of USD 370,000.00 under this main category.

Consultant Service: Total actual disbursed amount of US\$ 123,388.17 was made to the National and International consultants of PFMMP, which was 81% compared to the budget plan of USD 152,054.30. Since the payment to the International Internal Audit Advisor for the services completed in March 2015 was released in early April 2015, there were differences between the plan and actual expenditure.

Training & Workshop: During this quarter, the project could disburse up to US\$ 55,882.87 or 18% more than the budget of USD 47,536.00. Even though, some training activities could not be conducted as schedule such as the training activity of GDNAF and training of Legal Affair Department, the project disbursed up to USD 41,134.00 for unplanned activity based on the case-by-case approval from the World Bank. The remaining USD 14,748.87 was paid for local mission, GSC Retreat, Public Forum and trainings of GDIA. Therefore, it resulted in the differences between the plan and actual expenditure.

Incremental Operating Cost: The actual disbursed amount of USD 35,768.52 was for incremental operating cost comparing with the budget of USD 34,438.75. The over expenditure about 4% covered mainly on office supplies related to meeting arrangement.

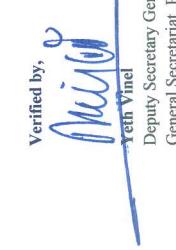
